Certification Statements:

1. I have verified the presence of all microchips listed, and the microchip was implanted prior to, or on the same day as, the most recent rabies vaccination.

2. I certify that the animals described have been inspected by me on this date and appear to be free of any infectious or contagious diseases and, to the best of my knowledge, exposure thereto.

3. I certify that the dogs described have been inspected by me on this date and do not appear to belong to a dangerous breed, a cross thereof, or possess physical traits similar to those of dangerous breeds (including American Staffordshire Bull Terrier (Amstaff), Bull Terrier, Argentinean Dogo, Japanese Tosa, Staffordshire Bull Terrier (English Staff), Pitt Bull Terrier, Brazilian Fila and Rottweiler) OR the owner has provided a copy of an Israeli import permit allowing for the movement of the animal.

4. All pets listed on this certificate are current on rabies vaccinations.

(NOTE: If the booster dose is inoculated during the period of validity of the previous vaccination, there is no waiting period before the importation of the animals. If primary vaccination is needed, or if booster does not occur during the period of validity of the previous vaccination, this booster should be considered a primary vaccination, and animals are required to wait at least 30 days prior to departure).

5. The animal has a rabies neutralizing antibody titer was equal to or greater than 0.5 IU/ml from an OIE-approved laboratory. The sample must be taken more than 30 days after the primary rabies vaccination, and the laboratory results are valid for the life of the animal, as long as the dog/cat remains current on rabies vaccinations, according the vaccine manufacture instruction.

Test Sample Date(s): _____

The health certificate must be endorsed by APHIS after it has been issued by a USDA Accredited Veterinarian. Any health certificate without APHIS endorsement is not valid for dogs or cats entrance to Israel.
