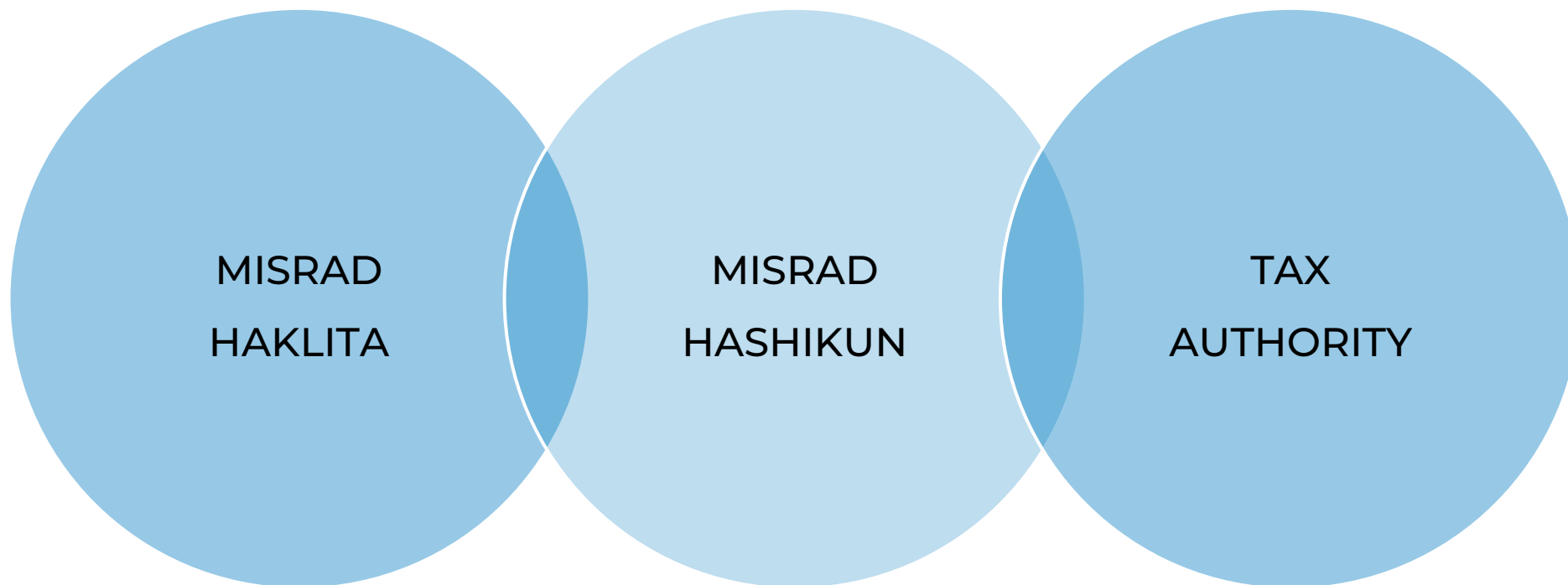

FREE HEALTH COVERAGE

🕒 Time Frame: 6 Months - 1 Year

- Eligibility
- 'Sal Briut'
- Supplementary Coverage

HEBREW ULPAN

🕒 Time Frame: 18 Months – 10 Years

- Free Hebrew Studies
- 5-5-5 Program
- Ulpan Location
- Explore Ulpan Options



New: Subsidized voucher for Hebrew study, level A, Pre Aliyah.

SUBSIDIZED HIGHER EDUCATION

🕒 Time Frame: 3 Years

- Time Frame – 3 Years from Aliyah
- Age Limit –
 - Up to Age 27: BA Studies
 - Up to Age 30: MA Studies
- Programs Recognized by the Student Authority
- Regular University vs. International Programs
- Army Service/ Sherut Leumi
- No Duplication of Degrees

Coming soon: Housing assistance. Those receiving tuition subsidy may be eligible for a housing stipend of 1,500nis per month for 2 years.



TAX BENEFITS

INCOME TAX REDUCTION

🕒 Time Frame: 4.5 Years

- Oleh Tax Credits
- Each Credit Point = 242 NIS
- Periphery Tax Break



TAX BREAK ON OVERSEAS INCOME

🕒 Time Frame: 10 Years

- Confirm Eligibility with an Accountant
- Only income tax, not BL tax
- Rule of thumb –

First 10 years do not need to report or pay

After that need to report:

- Active income will be according to tax treaty
- Passive income is likely to be double taxed

CUSTOMS BENEFITS

🕒 Time Frame: 3 Years

- 3 Shipments Customs-Free
- What is Considered a Shipment?
- Limitations



CAR BENEFITS

🕒 Time Frame: 3 Years

- Reduced Tax Rate – Purchase or Import
- Must Hold a Valid Israeli Driver's License
- Passport-to-Passport
- EV/ Hybrid Cars

CONVERSION OF DRIVER'S LICENSE

🕒 Time Frame: 5 Years

- License must be issued before Aliyah date
- The driver's license must be valid at the time of conversion
- Full driver's license – Not probationary or temporary
- Procedure for 2-5 years with a full local driver's license:
 - Eye exam
 - A short driving test
- Procedure for more than 5 years with a full local driver's license:
 - Automatic conversion
 - Since October 2021 – Licenses are valid until age 70

HOUSING BENEFITS

- Municipal Tax Discount
- Up to 90% Discount
- Determined by Local Municipality
- Eligibility

RENTAL ASSISTANCE

🕒 Time Frame: 8th Month Through 5th Year from Aliyah

Payments:

Year	8 th -12 th Months	2nd	3rd	4th	5th	6 th
Single	223	400	400	400	89	-
Family	402	800	600	400	99	-
Single Parent Family	402	800	600	400	223	134

- Subject to change

RENTAL ASSISTANCE

🕒 Time Frame: 7th Month Through 2nd Year from Aliyah

Payments:

Area	עדיפות לאומית	General
Single	1,336	~650
Couple/Family	2,000	~650
Single Parent Family	2,239	~650

- Payments run from 7th month of Aliyah through the end of the 2nd year of Aliyah

MORTGAGE BENEFIT

🕒 Time Frame: 15 Years

- Up to 180,000 NIS
- Government Mandated Interest Rates
- 20-28 Year Spread
